Executive Summary







- Collaboration and Partnership: Safe vehicles and safe people
- In the South East on 8th February we took part in a partnership-based compliance event at Membury Services on the M4. A total of 21 commercial vehicles were stopped and inspected during the event, with a variety of offences recorded. We worked closely with our partners including the Driver and Vehicle Standards Agency (DVSA) and police colleagues to spot and stop high risk behaviours, which included: driver hours offences, insecure loads, and dangerous tyres. Several drivers were issued with fixed penalties, four vehicles were issued with PG9 prohibitions until faults were rectified, and words of advice were given to others.
- The North West Regional Programme Manager sends out a monthly road safety update to over 1000 Regional based staff and external stakeholders. This is now being shared regularly as part of meeting safety moments. The February update focused on Mobile Phones and the law.
- The Regional Programme Managers, along with SES, have come together to develop plans for working in specialist squads to ensure that specialisms can be shared across regions and nationally. This will improve collaborative working as well as efficiency and consistency of approach.

Roads Policing Review – Strategic Policing Requirements 2023

Safe Vehicles and Safe People

This month the Home Office have published the <u>Strategic Policing Requirement 2023</u> (SPR). Thanks to the hard work of all the organisations that have been working on the Roads Policing Review (including significant contributions of resource and intellectual support from National Highways), the recommendations of <u>HMICFRS Roads Policing report</u> roads policing is now referenced as a capability in the SPR. This is a significant positive strategic policy development.

It means roads policing must be considered with due regard in policing and crime plans. This is a first and should lead to increased enforcement on our roads and will be linked to improved use of intelligence to maximise the impact of roads policing. National Highways have been a driving force in this review, working closely with Department for Transport (DfT) and the Home office (HO) by providing funding and resource to ensure the success of the review in which this is the first of the key achievements.

We have a set of rules about rest, planning it properly...Unfortunately we have lost colleagues who have taken their own lives. Its terrible for all involved, so desperately sad. A few years ago we engaged the services of a mental health counsellor. The results have been remarkable."
