


The National Incident Liaison Officer (NILO), Media and Police Reports provide some understanding on the number of fatalities on the strategic road network. Based on our current understanding there are 12 fatalities due to road traffic collisions and 2 suspected suicides in March. We have reviewed the historic number of fatalities in March for 2017 – 2020, this indicates that the average number of fatalities in the month of March was 16.5. In additional there is also a fatal casualty involved in a collision on 27th February who died on 2nd March taking the February monthly total from 8 to 9 fatalities. The locations of the fatal collisions and suspected suicides are plotted on maps of the SRN, red markers indicate a fatality during March and yellow markers are the previous 11 months on a rolling total.







Road User Performance and Road User Safety

- Breakdowns campaign on Wednesday 10th March we launched our biggest ever and much anticipated fully integrated, multi-channel 'emergency aware' driver education campaign on Breakdowns. The aim is to help increase driver confidence in what to do in the event of a breakdown including on a motorway, with or without a hard shoulder. The campaign forms part of Action 10 of the Smart Motorways <u>stocktake</u> 'more communication with drivers' and was developed working in partnership with the AA, RAC, DVLA, BIBA, Green Flag and Mobility as well as the DfT, DVSA and Police. The main message and creative concept is 'Go Left' which is the common theme that runs throughout our breakdowns advice e.g. indicate left, move into the left lane, exit left at the next junction/services, or exit left at an emergency area. Based on customer insight, the concept combines the Pet Shop Boys 'Go West' song (changing the lyrics to 'go left' and incorporating key breakdowns advice) with the quirky appeal of 'Bugs' into one treatment. The activity will run for 6 weeks including prime-time TV, radio, video on demand, out of home and digital displays at service stations, PR and social media advertising including YouTube, Facebook, Twitter and Instagram. Plus, partnership activity with 'Chunkz & Filly', social media personalities through Joe.co.uk. We've also developed a Breakdowns advice film, with the British Sign Language Association, to support our customers with hearing impairments and we are working with a social influencer agency, Purple Goat, to directly access the disabled community and those with hearing impairments.
- We supported West Mercia Police with some local comms activity as they started to use upgraded speed cameras for red X enforcement. A variable message sign 'Red X Enforced' was activated in the region and posts went out on Highways England and West Mercia police social media channels in the Midlands region. We are working with other police forces who are already enforcing Red Xs caught on camera (and those who will soon start to use upgraded cameras) to get the message out, in their regions, that cameras are now helping to keep motorists safer with this added level of enforcement. We are aiming to do some proactive PR and publicity on Red X over the coming months. On a national scale, we published a Red X Facebook recording on 22nd March on our corporate social media channels to discuss the importance of a Red X. Hosted by Jeremy Phillips, Head of Road User Safety at Highways England, the recording is a filmed conversation with a traffic officer, our national enforcement coordinator and guest Derek Firminger who represents the recovery industry. Facebook 'Live' events or recordings are a key part of the engagement work we do with strategic partners and the filmed conversations appeal to a wide range of road users.



Our Regional Safety Coordinators continue to deliver a range of activities, including delivering 2 Load Security Training courses in March whilst continuing to engage with the commercial vehicle sector using the Traffic Officer Service on commercial vehicle safety in the North West. The South West safety team have implemented the Regional Network Safety Performance approach to safety intervention in the region. This approach has been devised to identify issues that, when resolved, will result in a more intuitive and forgiving network and have a positive impact on star rating. Work has commenced on the A30 route between Exeter (M5 Junction 31) and Penzance, Cornwall. The route has been split into three sections with members of the safety engineering team analysing each section independently. The individual teams then come together to discuss the identified issues and decide upon consistent improvements throughout the route. This has identified a significant number of features that, if improved, will result in a reduction in the number and severity of collisions.

Road User Performance and Road User Safety – continued.

We have secured Openreach as a new DfBB partner and will also be joining the Van Reference Group led by the Commercial Vehicle Incident Prevention Team. Since first meeting with DfBB in 2019 Openreach have introduced a number of new policies and interventions to improve the safety of their driving workforce including developing their own internal speed awareness course, manager training days and re-siting roadside cabinets and poles that has reduced potential near misses by approximately 100,000. DfBB celebrated International Women's Day highlighting the success of women in the transport sector and particularly those in Highways England. A programme



of interviews are planned with key women leaders over the next 12 months, including Mel Clarke, Highways England's

Customer Service Director. DfBB contributed to improving the **Health and Safety Executive's work-related road risk guidance**, currently known as INDG382. Several staff from both the Strategic Safety Team and the wider DfBB team were interviewed as part of the refresh and DfBB used our campaign channels to promote engagement with the consultation in support of HSE.
