## **Executive Summary**

#### **Supply Chain**

The overall Supply Chain 12 month rolling RIDDOR AFR to October 2020 decreased from 0.07 to 0.06.

There were **3 RIDDOR** accident reported in October 2020.

There have been 25 RIDDORs in the rolling 12-month period.

**5 RIDDORs** have moved out of scope for the rolling RIDDOR AFR calculation.

The in-month RIDDOR AFR was **0.09** and the net 12 month recorded hours decreased by 0.22% (38.77 to 38.69m).

The Major Projects 12 month rolling RIDDOR AFR to October 2020 decreased from 0.06 to 0.05.

There were 2 RIDDOR accidents reported in October 2020.

**3 RIDDORs** have moved out of scope for the rolling RIDDOR AFR calculation.

The in-month RIDDOR AFR was **0.12** and the net 12 month recorded hours decreased by 1.06% (18.83 to 18.63m).

The Operations 12 month rolling RIDDOR AFR to October 2020 decreased from 0.08 to 0.07.

There was 1 RIDDOR accidents reported in October 2020 (& 1 incident for September that has subsequently been upgraded to RIDDOR reportable) 2 RIDDORs have moved out of scope for the rolling RIDDOR AFR calculation.

The in-month RIDDOR AFR was **0.06** and the net 12 month recorded hours increased by 0.58% (19.94 to 20.06m).

Incidents reported in month: There have been 7 Lost Time Incidents reported this month – 4 Major Projects, 2 Operations and 1 TO/RCC of which 3 were RIDDOR reportable.

Site Inspections: There have been 20 inspections carried out for October 2020 by the H&S Division, 10 in Major Projects and 10 in Operations

**Utility Strikes:** There have been **9** utility strikes reported this month - **3** Major Projects, **6** Operations

**Fatality Data:** The National Incident Liaison Officer (NILO), media and police reports provide information on the number of fatalities on the strategic road network. These data sources indicated that there had been **12 fatal incidents and 2 suicides** on the Strategic Road Network.

Vehicle Incursions: There have been 179 Vehicle Incursions reported this month

Impact Protection Vehicle Strikes: There has been 1 IPV Strike reported this month

Bridge Strikes: There have been 0 Bridge Strikes reported this month




#### **Graph 1 – Rolling AFR for Supply Chain - Major Projects**








#### **Graph 2 – Rolling AFR for Supply Chain - Operations**



#### **Fatality Data**

The National Incident Liaison Officer (NILO), Media and Police Reports provide some understanding on the number of fatalities on the strategic road network. Based on our current understanding there are 12 fatalities due to road traffic collisions and 2 suspected suicides in October. We have reviewed the historic number of fatalities in October for 2017 – 2019, this indicates that the average number of fatalities was 20.








## **Road User Performance and Road User Safety**

Our Operation Tramline Project appeared in Sky News and The Times after a 9 day operation where Surrey and Sussex Police forces used our unmarked HGV supercabs to patrol the A3, M3, A23, M25 and A27. Surrey and Sussex police found 285 drivers committed 305 offences including seatbelt offences, driving on the hard shoulder and other safety offences which resulted in 155 traffic offence reports being filed and 23 fixed penalty notices handed out. Cheshire police used the unmarked HGV supercabs and spoke with over 50 driver's offences such as seat belts, speeding, mobile phone use and overweight vehicles. Following the success of Operation Tramline, the contract for the three HGV cabs with the vehicle supplier, Dawsongroup, has been extended for 12 months and will now end in November 2021 and delivery of three new tractor units is expected in December 2020. Campaigns are scheduled for this extended period and will be subject to future updates. And finally, the M1 week of Action has been shortlisted for an award at the UK Fleet Champions Awards. The event will be taking place virtually on the 19 November.

• Six months into the COVID-19 pandemic, on the 13th October 2020, **Driving for Better Business** launched a <u>Better Business Resilience Report</u> which looks into how companies are dealing with the challenges they face, and preparing for the future post-COVID. To produce this report, Driving for Better Business surveyed 150 owners of SME businesses with a turnover of less than £10 million and who hire people who drive for work, plus another 150 board level decision makers in larger firms, to see how coronavirus had affected them and what plans they were making to strengthen their businesses and ensure their survival. One of the business benefits of good work-related road risk management is the ability to control and reduce related operational costs. The report highlighted how Driving for Better Business provides guidance and resources on how to achieve this. Driving for Better Business has also developed resources which will be distributed throughout and beyond our commercial vehicle community. These include flyers and stickers to help drivers access mental health advice, via the charity <u>CALM</u>, as well as van driver toolkit resources, such as '<u>Preparing for driving in the winter</u>'. Working in partnership with <u>TyreSafe</u>, we have also been sharing '<u>Are your tyres ready for ACTion</u>?' resources with our community. We presented an introduction to Driving for Better Business and work-related road risk to the Submarine Delivery Agency (SDA) who manage the procurement, in-service support and dispersal of UK nuclear submarines, and employs 10,000 staff to support both the public and private sectors in this enterprise. The feedback received was overwhelmingly positive and we will continue to work closely with attendees to register with the programme. The Ministry of Defence are traditionally heavily invested in matters of road safety - and this work with the SDA will be in the context of previous initiatives (both local and national) that are designed to help reduce risk amongst
