Executive Summary

Accident Frequency Rate (AFR) Overview:

The Major Projects 12 month rolling AFR to October 2018 decreased from 0.05 to 0.03.

There were **0** RIDDOR accidents reported in October 2018.

2 RIDDORs fell out of the scope of the rolling AFR calculation.

The in-month AFR was **0.00** and the net 12 month recorded hours increased by 3.20% (14.5m to 14.9m).

The Operations 12 month rolling AFR to October 2018 remained at 0.11.

There were 2 RIDDOR accidents reported in October 2018.

0 RIDDORs fell out of the scope of the rolling AFR calculation.

The in-month AFR was **0.11** and the net 12 month recorded hours increased by 2.61% (21.3m to 21.8m).

The overall **Supply Chain 12 month rolling AFR** to October 2018 **decreased** from 0.09 to **0.08**.

There have been 13 RIDDORs year to date and 29 RIDDORs in the rolling 12 month period.

2 RIDDORs fell out of the scope of the rolling AFR calculation.

The in-month AFR was **0.06** and the net 12 month recorded hours increased by 2.84% (35.8m to 36.9m).

Incidents Reported:

There were 4 RIDDOR accidents reported in October 2018 (Section 3/4 and Appendix 3/4).

Site Inspections:

There were **47** inspections carried out in October 2018 by the H&S Division, **18** in Major Projects and **29** in Operations (Section 10).

Fatality Data:

The National Incident Liaison Officer (NILO), media and police reports provide information on the number of fatalities on the strategic road network. These data sources indicated that there had been **26** fatalities on the Strategic Road Network (Section 7 and Appendix 5).




Graph 2 – Rolling AFR for Supply Chain - Operations




Key Activities This Month:

note is the improvement in South East performance.



• We recently received the International Road Federation (IRF Global) "Find A Way" Global Road Safety Award which recognizes outstanding commitment to improve road safety by national, regional, or city governments. The IRF Award Programs are set up to gather information on the exemplary/ground-breaking areas of work and seeks to promote and publicize best practice providing a road map for others to follow. The award is presented every year on the anniversary of the launch of the Decade of Action for Road Safety 2011-2020 and is based on nominations received from leading international organisations. The award for Highways England recognized leadership in road safety and activities being undertaken which reduce road fatalities and/or serious injuries.



National Health & Safety Team Update

National Health & Safety Team Update

a) Health and Safety Assurance reviews:

The audit schedule for October 2018 to March 2019 has been agreed by Mike Wilson, on behalf of the Executive Safety Committee. Furthermore, all scope areas have been, or are in the process of being discussed and agreed with the corresponding Executive Directors. Audit activity will begin in November with a focus on the management of statutory inspection across our estate.

b) Health, Safety & Wellbeing strategy:

The next version of the new home safe and well strategy is being developed, before being presented to the Executive Safety Committee. Similarly, governance and supporting documents are under review within the team with an intention to start directorate planning via Exec members, during November. A fuller update on progress will be provided at November's Executive Safety Committee.

- c) Innovation in Health, Safety and Wellbeing is increasing in pace and scope, with early projects starting to implement change.
- Signalling for road works (which uses VSS to eliminate manual installation/removal of temporary signs) is moving to the transition to becoming business as usual in the East RCC, with the plan for potential national roll-out being finalised.
- Formal links with Birmingham City University to develop a programme of applied research around incidents involving people and plant vehicles are now in place, with the advertisement for the first PhD student due to be published shortly.
- Work on the Automated IPV is focusing on the challenges of safely operating an automated vehicle on the SRN, which is still scheduled to commence in January 2019.

d) Highways England Supply Chain Health and Safety Incident Reporting IAN 128/15/C

The update to the reporting requirements was published on the 30th October under CHE 428/18. Following a number of asset failures which were not appropriately reported to asset specialists in order to consider any potential national impact, IAN 128 has been re-issued with clarifications to ensure that all asset failure incidents are reported correctly, providing consistent visibility to regional and national specialists for appropriate consideration and action. There have been occasions where the reporting of incidents and high potential near misses requiring notification to the Health and Safety division has not been within appropriate timescales and where there was uncertainty around lost time injury reporting requirements, these aspects have been clarified in this revision. Requirements incorporated into IAN 128/15/C:

- The notification of Health and Safety and asset incidents within 2 hours of the event occurring or being identified.
- The entering of the event on to AIRSweb within 24 hours of the event occurring or being identified.
- The provision of an initial report and upload to AIRSweb within 3 working days of the event being notified.
- The provision of a final report and upload to AIRSweb within 10 working days of the event being notified.
- The uploading of the hours worked in the month to AIRSweb by the close of working day 1.
- e) Safety Alerts: There were 2 Safety Alert issued in the month:
- HEi056 Highways England Safety Alert <u>Trip and fall resulting in fractured knee</u> HEi057 Highways England Safety Alert - <u>Positive Legionella Test</u>
